- 3. All information and services available on the District's networks are placed there for educational purposes, which I use at my own risk and without warranty. District staff members are not liable for any damages incurred in connection with the use, operation or inability of the District's networks, equipment or devices.
- 4. I acknowledge that my choice to use personal technologies in a District building, on school grounds, or at a school-sponsored activity at any location, in any manner that would otherwise violate Board policy, shall result in disciplinary action. Such discipline may include confiscation of the personal technology, loss of technology privileges, and other penalties and disciplinary actions up to and including suspension and expulsion.

I have read this agreement form and related policies. I agree to abide by these expectations and requirements. I agree to uphold my responsibilities as a user of the District's computers, networks and mobile devices, and to uphold the same responsibilities as a condition of using personal technologies in a school building, on school grounds, or at a school-sponsored activity at any location. I also understand that any violation of the regulations is unethical and may constitute a criminal offense. Should I commit any violation, my access privileges may be revoked and disciplinary action taken.
